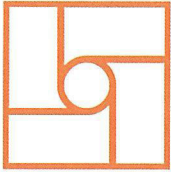
Sir/ Madam,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that Sharda Ispat Industries Limited, the resulting Company formed pursuant to the BIFR issued Order - Scheme of Demerger involving Sharda Ispat Limited ("the Demerged Company") and Sharda Ispat Industries Limited has on 15th April, 2025 submitted an application to BSE Limited for listing of its equity shares under Regulation 19 of the Securities Contracts (Regulation) Rules, 1957 and other applicable provisions.

The Scheme of Demerger was duly approved by the Hon'ble Board for Industrial and Financial reconstruction New Delhi Bench - III vide its order dated 21st January, 2010, under the provisions of the Sick Industrial Companies (Special Provisions) Act, 1985. The said Scheme provided for the demerger of Two units of Sharda Ispat Limited into two resulting companies, one of which is Sharda Ispat Industries Limited.

Sharda Ispat Industries Limited has now made an application to the stock exchange for the listing of its equity shares, subject to receipt of necessary approvals from the exchange(s) and other regulatory authorities.
